Extension Admission Notification 2019 – 20 - 21

Last date 10th December 2019

The online admission was started this year in July 2019 for various trades in Government ITI's of state including Govt. ITI Kishtwar. The Directorate of Technical Education issued selection List followed by two waiting lists. The last date for admission was 30th November 2019.

However, there are still several seats vacant in various trades of this Institute. **The Last Date for Filling these Leftover Seats is 10th December 2019.**

For filling vacant seats following criteria will be followed by this Institute :-

1. The remaining vacant seats shall be filled by this Institute from the merit List already issued for ITI Kishtwar on the basis of MERIT as well as FIRST COME FIRST SERVE BASIS.
2. The candidate/s who had opted for particular trade but has not been selected can opt for the vacant seat in another trade, even though he/she has not mentioned that trade while filling his/her online form.
3. In case there still remains vacant seat/s in trade/s of this Institute till 7th December 2019. Fresh candidates are invited to approach the Training Section and are asked to remain in touch with this Institute for filling of Admission Forms (OFFLINE). However, the Last date for Admission will remain same i.e 10th December 2019.
4. All Admission process will be carried in the Training Section, Block A of this Institute.
