Admission Notice

Online applications are invited from the Permanent Residents of Jammu & Kashmir State for seeking Admission in **Govt ITIs** for the Academic Session 2019-20 in various Engineering / Non Engineering trades having duration of Two Years / One year / Six months being run under NCVT/SCVT Scheme and commencing from August 2019.

Candidates having minimum age of 14 years, as on 1st June 2019 ,with no upper age bar (except Driver cum Mechanic LMV trade, for which minimum age is 18 years) can apply. The desirous candidates have to fill up the admission forms online available at ITI admission link(<http://itiadmissions.jkdte.org>) present on the official website of Directorate of Technical Education J&K i.e. www.jkdte.org.

The last date for applying online is upto 23rd of July, 2019. The details pertaining to trades functioning in various Govt. ITIs, for which admissions are to be made for the session 2019-20 for Free and Self Financing seat are available in the portal only and can also be sought from the concerned ITIs.

The Candidates have to fill up the complete details which include Basic Details of the Student like Name ,Parentage etc and Qualification Details online in the portal and have to upload the soft copy of the following documents online only:-

1. State Subject / Permanent Resident Certificate.
2. Marks Certificate of Qualifying Examination.
3. Date of Birth Certificate.
4. Category Certificate (SC/ST/Ex.Serviceman/Physically Handicapped/EWS) if any.

The candidates will be required to deposit application form fee against cash receipt in the respective ITIs in which they are seeking admission and then will be required to upload the Fee Receipt in the portal before finalizing the Application Form.

The Application Fee will depend upon the Number/Type of Trade Preferences, the candidate is opting for. For upto four(4) Trade Preferences in one ITI, except Self-Finance Schemes , the fee applicable will be Rs 40/- and Similarly for upto four(4) Preferences of Self-Finance Schemes Rs 40/- is applicable. The actual application fee for the application will also be depicted in the portal, as and when the preferences are made.

It is pertinent to mention here that the candidate **has not to submit any hardcopy of the application form**. The detailed guidelines for verifying the application forms by the ITIs will be issued separately to the institutes.
