### Admission Notice - Govt. ITI Kishtwar **Customised Crash Course Programme for COVID Warriors** (HEALTH SECTOR)

COVID-19 has put our existing healthcare system under unprecedented stress, and it was felt that there is a requirement of skilled COVID warriors across the country. In order to meet this deficit of skilled COVID warriors and augmentation of available healthcare services with limited span of time, Ministry of Skill Development and Entrepreneurship (MSDE) has undertaken a programme to create a pool of trained/skilled COVID warriors with scale, speed and as per standardised skilling ecosystem.

Accordingly, the 'Customised Crash Course Programme for COVID Warriors' is designed as a special programme for its effective implementation under Special Project category of Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) The present programme has been devised specifically keeping in mind the COVID-19 related challenges and to enable a robust response mechanism to any ensuing COVID-19 related exigency.

The training under this component will be conducted on customised crash courses in below identified job roles suggested by Healthcare Sector Skill Council (HSSC). The training duration will be of approximately 21-days of theory-based classroom training followed by approximately 90 days On-the-Job Training (OJT) in healthcare facility.

The candidates may be paid stipend @125 per day for 90 days OJT period directly into their Aadhaar linked bank accounts through Direct-Benefit Transfer (DBT) process and after passing the assessment. The Stipend shall be transferred to Aadhaar linked and Active bank account only. The office shall not be responsible for non-payment of stipend due to wrong details/inactive bank account.

The training would be imparted in customised below job roles for District Kishtwar through J&K State Health Society, National Health Mission linked health institutions. The candidate may choose between any of the following courses subject to availability of the course in the training centre.
