ITI Kishtwar** for the academic session 2022-23-24 in various Engineering/Non-Engineering Trades having duration of Two years/One year for **free & Self-finance seats** being run under NCVET/SCVET Scheme and classes commencing from September 2022 for which the forms can be uploaded from **18**<sup>th</sup> **of June 2022**.

The candidates after finalizing the profile and application online will be required to deposit the printout of the system generated application completed in all respects along with self- attested photocopies of above-mentioned required documents uploaded on the portal at ITI Kishtwar within the stipulated time line and also have to deposit the prescribed fee of Rs.100/- (One hundred only) per three trades (03) against a proper cash receipt from Govt. ITI Kishtwar.

- 4. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade two years after completion of previous training course. However, for the ensuing academic session their admission is considered in any of the trades having poor response.
