III) Brief overview for Filling ONLINE admission Form :-

The candidate has to follow below sequences for completing his/her/others online admission process:

- 1) Enroll: Use a valid Mobile No to register vide OTP, create password and thereafter starting admission process.
- 2) Photo: Upload latest Clear Photo.
- **3) Personal Details** (**Spelling**, **Data** strictly as per 10th Qualification marks card for 10th Basis trade & as per 8th/10th Qualification marks card for 8th Basis trade) :- Candidate Name, Fathers Name, Mother Name, Permanent Address, DOB, Category, Disability, Ex-Servicemen, Gender, Valid Email ID, Aadhar Card Details
- **4) Qualification Details**: Basic Qualification desired for trade such as 8th, 10th, 12th. Higher qualification if any acquired as graduation, etc could also be mentioned.
- 5) Upload Documents :- Softcopy of original/self-attested of below documents are to uploaded
 - a) Date of Birth Certificate.
 - **b)** Marks Certificate of Qualifying Examination.
 - c) Category Certificate (SC/ST/Ex. Serviceman/Physically Handicap/EWS), if any.
 - d) (**Domicile Certificate should be produced at the time of admission in the respective ITI)
- **6)** Creating Application/Admission Form: After submitting above data, create Application/Admission form for the Selected ITI (ITI Kishtwar) and selected the trade/s.
- **7) Payment of application Fee**: Approach to ITI Kishtwar, Accounts Section, along with a printed copy of above application form for depositing admission form Fee (@ Rs.40/per trade)
- **8) Upload Fee Receipt**: Approach to Training Section for upload and approval of payment-receipt, thereby ensuring submission of application/admission forms for selected trades.
- **9)** Submission of Hardcopy: The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application in the training section of ITI Kishtwar along with self-attested photo copies of above mentioned required documents.

IV) Important Note:

- 1. Selection will be made purely on the basis of academic merit obtained by the applicants in their qualifying examination (both for free and self-financing seats separately).
- 2. On successful completion of training in trades running under NCVT/SCVT Scheme, certificate will be awarded by National / State Council for Vocational Training.
- **3.** Candidates who have already undergone training in any of the trades in any ITI can apply for admissions in another trade after two years after completion of previous training course. However, for the ensuing academic session, their admission can be considered in any trade having poor response.
- **4.** The detailed guidelines for filling the application forms by the candidates is also available on ITI Admission Portal. In case of any technical issues kindly mail on helpmesbote@gmail.com.
- 5. Candidates having minimum age of 14 years, as on 1st June 2020 are eligible for admission.
- 6. Admission in self-finance trade is subject to 80% enrollment of intake capacity.
